- Planned expenditure for 2017/18 includes a further club jacket order, some SI

 balance of the CompassSport Trophy expenses.

The Treasurer then opened for questions about the accounts and any ideas for expenditure, but there were none forthcoming.

Ruth Ker proposed that the accounts be accepted. This was seconded by Allen Banister and approved unanimously. The Treasurer proposed a vote of thanks to Harry Dowdell for his work in auditing.

5. Membership fees
